FASTEST IOBS GROWTH

The extensive legal business base contributes to the £11.5 billion GVA of the region's wider financial, business and professional services sector. Between 2010 and 2015 Leeds experienced the fastest legal sector jobs growth in a major legal centre, ahead of London, Manchester, Birmingham and Bristol¹ with employment increasing by 20 per cent in this period, almost five times the rate of growth in London².

Leeds also recorded the fastest growth in solicitors firms amongst major UK legal centres².

LEGAL INVESTMENT GROWTH TIMELINE

US-owned **Squire Patton Boggs** moved over 200 staff to a new Leeds office at Wellington Place to benefit from a raft of facilities, including a client suite, collaborative office working space and a rooftop terrace

International law firm **Addleshaw Goddard** completed its move to 3 Sovereign Square, a landmark new development for over 460 members of staff

2017 The Government Legal Department (GLD) announced it is opening a regional centre in Leeds

Leeds-based Bond Dickinson LLP and USbased Womble Carlyle Sandridge and Rice, LLP combined to create **Womble Bond**

2018 Innovative law firm **Rradar** expanded into Platform as the firm more than triples the size of its team

Shoosmiths, who originally agreed a 10 year lease at Platform has now signed up for an additional wing to grow its team and service a growing client base

Walker Morris are moving to a new office in Leeds which is undergoing a £10 million refurbishment, bringing 500 of its staff together under one roof. This investment will make Walker Morris the largest single site law firm outside London

Reed Smith launched Reed Smith Global in Leeds to provide a creative environment for lawyers, analysts and business service professionals

The **Ministry of Justice** announced it will move to 5 Wellington Place attracted by modern collaborative working environments and the proximity to the train station
